

This document outlines our policy relating to any Personal Information [defined below] YOU provide us.

Introduction

We, at 'Hayagriva Software Private Limited' ["We" or "Hayagriva"] are committed to respecting your online privacy and recognize your need for appropriate protection and management of any personally identifiable information ("Personal Information") YOU share with us.

Personal Information means any information that may be used to identify an individual, including, but not limited to, a first and last name, a home or other physical address and an email address or other contact information, whether at work or at home, as well as information about your computers and/or other devices which YOU use to access http://www.comsur.biz/ and/or the products and/or services that Hayagriva may provide. Cookies and Other Tracking Technologies

Some of our Web site pages may utilize "cookies" and other tracking technologies. A "cookie" is a small text file that may be used, for example, to collect information about Web site activity. Some cookies and other technologies may serve to recall Personal Information previously indicated by a Web user. Most browsers allow YOU to control cookies, including whether or not to accept them and how to remove them.

YOU may set most browsers to notify YOU if YOU receive a cookie, or YOU may choose to block cookies with your browser, but please note that if YOU choose to erase or block your cookies, YOU will need to re-enter your original user ID and password to gain access to certain parts of the Web site.

Tracking technologies may record information such as Internet domain and host names; Internet protocol (IP) addresses; browser software and operating system types; click stream patterns; and dates and times that our site is accessed. Our use of cookies and other tracking technologies allows us to improve our Web site and your Web experience. We may also collect and/or analyze information that does not contain Personal Information for trends, statistics, and any other reason.

- We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data.
- We may allow access to your Personal Information to anyone who needs to know that information in order to operate, develop or improve our services. Updating your information We may provide mechanisms for updating and correcting your Personal Information for our services.

Children

- Hayagriva will not contact children under the age of 18 about special promotions or for marketing purposes without a parent's permission.
- Hayagriva does not ask a child under the age of 18 for more Personal Information, as a condition of participation, than is reasonably necessary to participate in a given activity or promotion.

Information Sharing and Disclosure

Hayagriva does not rent, sell, or share Personal Information about YOU with other people or nonaffiliated companies except to provide products or services YOU've requested, or when We have your permission, or under the following circumstances:

- We provide the information to partners who work on behalf of or with Hayagriva under confidentiality agreements. These companies may use your Personal Information to help Hayagriva communicate with YOU about products or services from Hayagriva and themselves. However, these companies do not have any independent right to share this information.
- We have a parent's permission to share the information if the user is a child under the age of 18.

- We believe it is necessary to share information in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Hayagriva's terms of use, or as otherwise required by law.
- We will transfer information about YOU if Hayagriva is acquired by or merged with another company.
